R1	Art. 1 no. 4 of the representation agreement: With respect to <b>sound recordings</b> the right exceeding Article 86 UrhG concerning the non-interactive transmission of sound recordings via <b>simulcasting or webcasting</b> via <b>mobile networks</b> , for which services are configured, regardless of being personalised or having skip- and/or pause-functions
R2	Art. 1 no. 4 of the representation agreement: With respect to <b>sound recordings</b> the right exceeding Article 86 UrhG concerning the non-interactive transmission of sound recordings via <b>simulcasting or webcasting</b> via <b>internet</b> , if <b>personalised services</b> or <b>services with skip- and/or pause-function</b> are concerned
R3	Art. 1 no. 5 of the representation agreement: With respect to <b>sound recordings</b> the right to make available to the public performances recorded onto published sound recordings or conventionally broadcast via commonly accessible pages on the internet or mobile network services through the broadcaster (" <b>podcasting</b> ")
R4	Art. 1 no. 9 of the representation agreement: With respect to <b>sound recordings</b> the right to make copies and to <b>distribute</b> a conventional broadcast already used for broadcasting purposes via <b>physical storage media</b> of any kind (" <b>DVD-tariff</b> ")
R5	Art. 1 no. 2 of the representation agreement: With respect to <b>sound recordings</b> the right exceeding Article 86 UrhG concerning the non-interactive transmission via <b>IP-TV</b> and subject to the usage of new transmission standards for mobile reception or in mobile networks
R6	Art. 1 no. 8c of the representation agreement: With respect to <b>music video clips</b> the right concerning the non-interactive transmission via <b>IP-TV</b> and subject to the usage of new transmission standards for mobile reception or in mobile networks
R7	Art. 1 no. 8a of the representation agreement: With respect to <b>music video clips</b> the right to conventional <b>broadcasts</b> by broadcasting enterprises in <b>comprehensive and specialist TV programmes</b> (except for specialised music programmes)
R8	Art. 1 no. 8b of the representation agreement: With respect to <b>music video clips</b> the right to conventional broadcasts by broadcasting enterprises in <b>specialised music programmes</b> (i.e. those programmes with a content of the relevant audio-visual carriers of over 70%)
R9	Art. 1 no. 6 of the representation agreement: With respect to <b>sound recordings</b> the right to make available published sound recordings as <b>background music on websites</b>
R10	Art. 1 no. 8e of the representation agreement: With respect to <b>music video clips</b> the right to <b>simulcast</b> via internet or mobile networks
R11	Art. 1 no. 8f of the representation agreement: With respect to <b>music video clips</b> the right to make available to the public performances recorded onto published sound recordings or conventionally broadcast through broadcasters (" <b>podcasting</b> ")
R12	Art. 1 no. 9 of the representation agreement: With respect to <b>sound recordings</b> the right to make copies and to make available to the public, also via internet, a conventional broadcast already used for broadcasting purposes (" <b>audio- and video-on-demand</b> " except " <b>podcasting</b> ")
R13	Art. 1 no. 8 g of the representation agreement: With respect to <b>music video clips</b> the right to make available to the public via internet a broadcast of own or commissioned music events with a show character within six weeks prior to the first transmission of the music event (" <b>on demand announcement of music events</b> ")
