Introduction

my.gvl is the portal for eligible artists represented by GVL. A central feature is the product search, where productions can be found and accessed in which the artists have participated. Using the identified products, users can report their own contributions. This active registration of a contribution is a prerequisite for receiving remuneration by GVL. In the following, we would like to introduce you to how the product search works, along with other features of my.gvl.

Prerequisite for portal usage: the rights management agreement

In order to use GVL's artist portal my.gvl, you must be an eligible rights holder represented by GVL. This requires entering into a rights management agreement. The agreement enables GVL to manage your neighboring rights from secondary exploitation and distribute the revenues to you. The rights management agreement can be applied for online via the following link:<https://gvl.de/en/rights-holders/performers/online-rights-administration-agreement>


Once the rights management agreement is concluded, access to the my.gvl artist portal will also be set up."

Login and navigation

You can access the portal by entering <https://www.mygvl.de> in the address bar of your browser or by clicking on [this link](#).

Change language

You can already choose between the languages German and English on the login page of my.gvl. The menus and information provided will be displayed according to the language setting. The language selection can be found in the top right corner of the login window.



You can also change the language setting at any time after logging in. Click on the globe icon in the top right-hand corner to change your selection.

Setting up a password and logging in

As soon as the rights administration agreement has been finalized, you can use the artist portal. To log in, you will need your contract number - which you will find in your contract and usually in our initial e-mail correspondence - and a password. You must choose this password yourself when logging in for the first time. For this purpose, a link will be sent to you by e-mail. If this is not the case, you can also set up a new password yourself.

To do this, proceed as follows:

1. Open <https://mygvl.de> in the browser
2. On the login page, click on the "Forgot password?" link.

3. On the page that opens, enter the contract number assigned to you by GVL and click on the "Renew your password now" button.
4. An e-mail will now be sent to the e-mail address registered with GVL, containing a link to set your password.
5. Open the link and follow the instructions for assigning a password.

After you have successfully assigned a password, you can now log in to our artist portal [my.gvl](#) with your contract number and the password you have chosen.

my.gvl starting page

After the successful login you will reach the starting page of my.gvl by default. Here you will find current news and important information for artists. By clicking on a news item, you can view the entire text. The "Back" button at the end will take you back to the starting page.

At the top right you will find some buttons or icons.




The **bell symbol** leads you to cases that require your assistance, e.g. [open cases](#) where evidence of your contribution needs to be provided.

The **question mark symbol** leads you to FAQ, video instructions or the “Documents and forms” section on gvl.de.


At the **globe icon** you have the option to change the language setting at any time and switch between German and English.

The **playing piece icon** displays your name after a mouse click. You can access the “My data” section from there, where you can view and update your personal information. Under “My documents” you’ll find your payment notifications and detailed reports. “Memberships” leads you to the member administration for choirs/orchestras. To log out of my.gvl, simply use the “Logout” option.

The **main menu** of my.gvl can be found at the top, left side of the page. In the collapsed state, you will see three horizontal lines as a symbol - a so-called hamburger menu.



When unfolded, the menu items are visible. The menu can be closed again by clicking on the large X.


The services and the help section are provided with submenus that can be opened and closed by clicking on the arrow icons and lead you directly to separate subpages. We would like to briefly introduce these in the following.

Register contributions

In order to register contributions, first check whether the corresponding production or 'product' (in data terms) is available in the GVL database. You can access the product search by clicking on the 'Register contributions' entry in the main menu.

On the start page of the product search you will find

- a **free text field** in which you can enter your search terms (1),
- -a **category selection** to search for specific media types, with special search and filter options (2),
- -the general filters "**Hide all reported**" (3), "**Only products according to §79a**" (4) and "**Broadcast**" (5),
- the **result list** with found productions (6). This contains results as soon as you have successfully carried out a search.

Free-text search

The free-text search is the basis of the search process. It searches all products in the database for the entered term(s) and returns any relevant hits.

The free text search checks the following areas of the product information:

- Title, album title, episode title, original title

- Main artist
- Cast lists including role names
- Broadcast content information
- EAN, label code, ISRC
- Episode/Season numbers
- GVL product ID

Please note that not all information is always available.

With the X at the end of the input field you can delete your input again.

If the number of hits is too large and you cannot find what you are looking for, **general filters** can limit the search result of the free-text search (see below). In addition, you can **use quotation marks** to search for terms in context and thus obtain more precise results. Please note that this is not an "exact" search in the literal sense, as particularly common words, such as articles, are ignored.

In addition, it is possible to **select a category** (film and series, sound recordings, radio productions, stage productions, video clips) in order to view only certain types of media. Within the categories there are additional filter options, which are described below.

A search can only be executed if the free text field is filled with **at least two contiguous characters**.

To start the search, click on the blue magnifying glass icon or press the Enter key after entering the search terms.

Alternatively, it is possible to leave the free text field empty but select a category and perform a search via the magnifying glass icon. Filters can be used optionally afterwards.

General filters


Hide all reported

The filter "Hide all reported" can be switched on and off by setting a check mark in the square. It restricts the search results in such a way that productions for which a contribution registration of the logged-in beneficiary already exists are no longer displayed.

Broadcast

If this filter is set, the result list will only show products for which usage information, i.e. broadcast information, is available. If the filter is not used, the results list will also show products without recent broadcasts.

Please note that the database is not a reference work for past broadcasts. Old broadcast information that is no longer required for distributions can be successively deleted.



Optionally, the results list can be limited to broadcasts within a specific time period. The entry field for the time period (in the format DD.MM.YYYY) with a start date (1) and an end date (2) is only activated when the filter is selected.

- Earliest possible date: 01.01.2010
- Latest possible date: the current day

CET applies.

It is **not mandatory** to enter a time period.

Special entries:

Single entry in "Start date" (without entering an end date): shows all products with usages from the start date to the current date.

Single entry in "End date" (without entering a start date): shows all products with uses from 01.01.2010 to the selected end date.

Only products according to §79a

If this filter is set, only products with extension of the term of protection according to §79a UrhG are displayed

In the result list, you can recognize the corresponding products by the paragraph symbol ("§").

Categories and category-dependent filters

Please note: the use of the category-dependent filters is optional. Here you can make entries that improve the search result and, for example, narrow it down further if necessary. More about this in the section "[Example search queries](#)".

After selecting a category, a separate filter area opens, which can be expanded and collapsed via the arrow symbol in the upper line. Here in the picture, for example, the category "Sound Recordings":

Since some of the filters are displayed in several categories, the filters are described here individually and not bundled by category. A table below shows in which category the filters are present in each case.

Free-text search "Product title"

The products are searched only in the field "Production title" based on the search terms entered here. In this way, search results can be better narrowed down if necessary.

Free-text search "Composer"

The products are searched for listed composers based on the entries in this field.

Free-text search "Producer"

The products will be searched for listed producers based on the entries in this field.

Free-text search "Main Artist"

The products will be searched for listed main artists based on the entries in this field.

Free-text search "Director"

The products will be searched for listed directors based on the entries in this field.

Free-text search "Broadcast Content"

The products will be searched for according entries in the field "Broadcast Content".

Filter "Type"

The filter "Type" is only available in the category "Radio Productions". It offers the option to search either for "Radio Productions Music" or "Radio Productions Voice", the latter referring to spoken word contributions, mostly in German.

The filter offers both options in a drop-down menu. If no option is selected, all radio productions are displayed.

Filter "Genre"

This filter allows you to filter by the relevant genres depending on the selected category.

In the "Film and Series" category, the selectable genres are:

- Soap Telenovela
- TV film
- Anime and cartoon films TV
- Series
- Cinema movie

- Anime and cartoon films cinema
- Anime and cartoon film series

Please note: "cinema film" in this context means that the film has been produced for distribution in cinemas. For remuneration, a production must have been broadcast on a station under evaluation by GVL.

In the category "Sound Recordings" the selectable genres are:

- Classical music
- Audiobook/radio play
- Popular music
- Archive music
- Children's programme
- Theatre/Comedy

In the "Radio Productions" category, the "Type" filter must first be used to determine whether the production is a "Radio Productions Music" or a "Radio Productions Voice".

In the "Radio Productions Music" category, the selectable genres are:

- Archive music
- Classical music
- Popular music

In the category "Radio productions word" the selectable genres are:

- Audiobook/radio play
- Children's programme
- Radio Feature
- Cabaret

In the "Stage Productions" category, the selectable genres are:

- Theater/Comedy
- Classical music
- Popular music

There are no subordinate selectable genres in the "Video clips" category.

Filter "Country of Recording"

Choosing a country of recording from a list will search the products for the selected country.

Filter "Country of Production"

Selecting a country of production from a list will search the products for the selected country.

Filter "Year of Production"

Restricts the search to selected years of production (value range: 1901 to current year).

Note: For sound recordings, the production year is not as important as the recording year and is not always contained in the product data.

Filter "Year of Recording"

Restricts the search to selected years of recording (value range: 1901 to current year)

Filter "Radio stations"

The filter "Radio stations" allows to limit the search to products broadcast on specific radio stations.

The selection is made via a drop-down menu, which provides possible radio stations.

Note: Not every radio station is also relevant for distribution. For an overview of the distribution-relevant stations, please check the [distribution plans](#).

Filter „TV stations“

The filter "TV stations" filter makes it possible to limit the search to products broadcast on specific TV stations.

The selection is made via a drop-down menu, which provides possible TV stations.

Note: Not every TV station is also relevant for distribution. For an overview of the distribution-relevant stations, please check the [distribution plans](#).

Series Filter

Ticking the "Series filter" box in the "Film and series" and "Stage productions" category activates three specific filtering options.

All filters can be applied individually, as well as combined with each other.

Episode title

This filter enables a free-text search in the corresponding field.

Episode

This filter allows to narrow down episode numbers within the range of available products provided with corresponding information.

Season

This filter allows to narrow down season numbers within the range of available products provided with corresponding information.



The result list

When a search is performed for the first time, the search results are sorted in descending order based on the closest match to the search query ("Best Search Results").

The product display in the results list always shows at least a product title and a unique Production ID as well as additional attributes that depend on the respective media type. The media type is represented by an icon in the upper right corner.

- Broadcast Content
- Broadcasts
- Contributors

If a field is too long or contains several entries, more information can be found in the detailed view of the product. This can be expanded and collapsed via the arrow symbol.



The toolbar

Besides the text information, all products also include a toolbar.




- If the **playing piece icon** (1) is blue, this indicates that at least one contribution has already been registered by the logged-in beneficiary for this product. If no contribution has been registered yet, the icon is gray.
- The **transmission tower symbol** (2) in blue indicates that at least one piece of usage or transmission information is available for this product. You can see this in the detailed view. (In the case of played audio recordings, however, there is no individual listing of the broadcasts). If no such information is available, the symbol is gray.
Please note: Since the selection of stations evaluated by GVL changes annually, the presence of usage information does not necessarily mean that remuneration will be paid.
- The **collective product symbol** (3), when colored blue, indicates that it is an album or a radio concert with several tracks. Contributions cannot be registered on the collective product, but only on the associated individual products.
- The **paragraph symbol** (4) indicates that the product has an extended term of protection according to §79a UrhG. For all other products, the symbol is not present.
- The “**Bookmark**” **button** (5) adds the product to the list of bookmarked products by clicking on it, in case you want to register a contribution at another time.
For more information on this function, see the ["Bookmarked"](#) chapter.
- The “**Report**” **button** (6) initiates the registration of a contribution by clicking on it. Alternatively, you can also use the “Report” button on the right-hand side.
The chapter “How to register contributions” further down describes the process. In addition, there is information on how to submit bundled registrations for several related products at once, e.g. episodes of a series.

How to register contributions


Important: Before registering a contribution, please make sure that you have not yet registered an identical contribution for the corresponding product. Identical contributions on a production lead to the data situation becoming confusing both for you as the beneficiary and for us. Existing contribution registrations can be recognized as described above by the fact that the **playing piece icon** in the results list is blue. Details on the respective contributions can be found in the "Registered" section.

Contributions are registered via the so-called report dialog, initiated by the "Report" button on the corresponding product.








     

In addition, individual products in the results list can be subsequently deselected or re-selected by clicking on the square next to the corresponding title.

Please note: No contribution registrations can be submitted on a collective product (e.g. an album or a radio concert with several tracks), only on the associated individual products.

The report dialog

After clicking on the “Report” button, the report dialog in which you finalize your contribution registration opens. Here you are progressively asked for additional information regarding your contribution.



- The **upper half** (1) first displays the title and additional information (product number, duration, category and rubric) for the selected production.
- The **drop-down menu** (2) asks for the contribution role, i.e. in which activity you were involved in the production. Depending on your selection, further fields will appear that ask for additional parameters regarding your contribution.
- Clicking **Cancel** (3) closes the message dialog window and returns you to the product search. The same applies to the X at the top right of the window.
- If you want to register your contribution anonymously, you can do so by clicking on the corresponding **box** (4).

A **progression bar** (5) in the middle of the window shows the process of data entry for the registration on the corresponding production.



- Depending on the type of contribution, further input fields will open in the **title list** (1). Here you will be asked for specific parameters of your contribution registration. These differ depending on the contribution role. In the first example (Figure 1), you are asked for the role name and the number of recorded takes for registering as a dubbing actor. The second example (Figure 2) shows a report for a music production.

- The **button “Submit”** (2) in the lower right corner allows you to complete the registration. The button is grayed out and deactivated until all required information has been entered.
- If you want to submit another report - for example for a contribution in another function - for the selected production, simply check the **corresponding box** (3).

After successfully registering a contribution, a text will appear confirming receipt. The window then closes automatically and takes you back to the product search. If several productions were selected before which could not be bundled, a new reporting dialog will automatically appear after each submission.

Bundled reports

In some cases, contributions can also be registered in bundled form:

- In the "**Film and Series**" category, productions with identical titles (usually episodes of series) that have been selected at the same time are shown bundled in the report dialog (see Figure 4).
- In the category "**Sound recordings**", all productions selected at the same time are shown bundled together. In this way, identical contribution types can be registered in one go if, for example, you were a permanent band member or studio musician for all tracks (see Figure 5).

In such a bundled report, a **product collection** including the number of products intended for reporting is summarized in the upper third (1). In the lower part of the page there is an **overview** (2) of the selected productions with the corresponding production number. By clicking on the boxes, individual results can be selected or deselected and thus excluded from or added to the report. A click on "**Apply for all**" (3) selects all titles selected in the product search for the report.

By clicking on "**Cancel**" (4) the reporting process will be terminated prematurely and you will return to the product search. If further contributions are to be registered for these selected products, check the box "report additional participation" at the bottom right of the page. When all necessary parameters have been entered, the bundled report can be submitted via the corresponding **button** (5).

Example search queries

A few basic tips on how to search for products:

1. Make it as simple as possible. The use of filters is optional. They are there to narrow down the number of hits if a search has too many results. In many cases, however, it is quite sufficient to search for the name of a production and, if necessary, to limit it to a category.
2. Add filters only selectively. If step 1 does not lead to the desired result, another single filter may help:
 - In the case of sound recordings, it is often purposeful to make an entry in the field "Main artist".
 - In the category "Film and series", for example, an entry in the field "Director" often leads to the desired result.
3. Use quotation marks. In the free text search as well as the text filters you can also make use of quotation marks. In this way, the entire group of words is searched for. Deviating results will no longer be taken into account. The search for "SOKO Köln" will then no longer return results that contain only the terms "SOKO" or "Köln".

Of course, these are only examples. Other approaches are also possible. For example, you can search for your own name in the free text field or, if necessary, in the "main interpreter" field. Please note, however, that not all names are always stored in the production data.

Some example search queries can be found in the following section.


If you are an **actor or actress** and have played a consistent role in a series (in this case a daily soap) and would like to register your contribution, it may be helpful to use the series filters of the product search.

- Enter the name of the series in the **"Search"** (1) field.
- Select the category **"Film and Series"** (2). Further filter options will then appear. Daily soaps usually have continuous episode numbers, with the help of which you can specifically report the episodes in which you have participated.
- It is also advisable to select the **"Hide all reported"** (3) option throughout the reporting process to avoid duplicate registrations.
- Next, select the item **"Series Filter"** (4).
- Under **"Episode"** (5), enter the corresponding episode numbers or the range of episode numbers for a longer period of participation. Then click the magnifying glass or "Search" to display the search results.
- You can report up to 100 episodes at once by first selecting 100 at **"Items per page"** (6). Now tick the checkbox **"Preselect 100 of ... search results"** (7) on the left above the search results, and then click the "Report" button.

In the next step, you only need to select the type of your contribution, enter your role name in the and, if applicable, the number of shooting days. Complete the registration process by clicking on the "Submit" button. See also ["The report dialog"](#).

The steps are very similar if you want to register a contribution as a **dubbing actor**. Let's assume you have dubbed a character that only appears in one particular episode of a series.

- In the "Search" (1) field, enter the name of the series and the title of the corresponding episode.
- Select the production category "**Film and Series**" (2). Then click on the magnifying glass or "Search" to display the search results. Normally, this should already lead to the desired result if both the name of the series and the title of the episode are unique.
- If the desired episode is not among the search results or the number of matches is too high, it may also be useful to use the series filters of the search mask.
- To do this, click on the "**Series Filter**" (3) item.
- Enter the name of the episode you are looking for in the "**Episode title**" (4) field. Then start the search process by clicking on the magnifying glass or pressing the "Enter" key.
- Now select the desired production from the hit list and click on "**Report**" (5). This will take you to the report dialog, where you can enter the type of contribution and, if applicable, the role name in the production as well as the number of takes. Click the "Submit" button to complete the registration process.



Let's assume you are a musician and you want to register your contribution to a certain song.

- To do this, enter the title of the song in the **"Search"** (1) field.
- Select **"Sound Recordings"** (2) as the category. Further filter options will then appear.
- It is also advisable to select the **"Hide all reported"** (3) button for each search to avoid duplicate registrations.


For this example case we are searching for the song "King Of Pain" by "The Police". Without specifying any other filters, more than 30,000 results will appear for this song.

- In this case, it is advisable to use the **"Main Artist"** (4) filter by entering "The Police" in this field and clicking the magnifying glass to search. After that, only releases with this song title by the band "The Police" will appear.
- To subsequently register your contribution in all search results, select the appropriate number of "Items per page" and click on "Check ...of ... search results" (depending on how many search results are displayed).

Overview of registered contributions

After you have successfully completed the registration process for one or more productions, they appear in the corresponding "Registered" area. It provides a detailed overview of the registrations we have received, the current state of processing and, where applicable, information on reasons for rejection.

There are several ways to access this overview. Either via the button "Overview of registered contributions" in the main menu on the left-hand side or via the "Registered" tab within the product search.

Filter options

To provide a better overview within the registered tab, for example to find certain reported productions faster, various filter options are available. To apply a filter, simply make a corresponding entry (numbers 1-4) and click the **"Apply filter"** button on the right. Alternatively, the filter process is also triggered automatically as soon as an entry is made.

Apply filter (1):

This is a free text field. Reported products are searched according to various parameters. These include the product title, the product id or the contribution number of an individual registration. Production number and contribution number are also displayed in the corresponding report entry. More on this below. This field requires an input of at least two characters.

Category (2):

Here, a drop-down menu can be used to filter within the different product categories - film and series, sound recordings, radio productions, stage productions, video clips.

Status (3):

By selecting one or more options with a click in the corresponding box, only those contribution registrations that match the corresponding processing status are displayed. More about [this in the following section](#).

Evidence (4):


By clicking on the corresponding field, you can choose whether you want to see contribution registrations for which evidence has already been submitted or for which no evidence has yet been submitted.

Active filters are displayed **in the bar below** the filter window and can be deselected again by clicking on the x.



Production list / hit list

Below the filters you will find - in the layout very similar to the product search - a list with the contributions registered by you. If active, these are limited by the applied filters. Like in the product search, you can select single or a certain number of productions and increase the number of "products per page" to a maximum of one hundred.



Clicking on the box "**Check X of Y products**" (1) marks all entries on a page. The number X represents the number of displayed contributions per page, whereas Y is the total sum of products on which one or more contributions registrations are listed.


By clicking on the "**Report**" button (2), you can register additional contributions if you participated in more than one function.

Via "**Export all contributions**" (3) all registered contributions can be exported and downloaded as an Excel spreadsheet. The download starts automatically.


Please note: Currently it's only possible to export a maximum of 10.000 contributions. If you've submitted more contributions, please contact us.

In addition, all product details displayed on one page can be expanded by clicking on the **opposing arrows** (4).

If you have used filter options to display certain productions or contributions, it is also possible to export only this selection. In this case, the button appears as a **drop-down menu** (1), where you can choose between exporting all or only the filtered contributions.



The “Registered” section displays the productions for which the logged-in authorized person has registered contributions. They are sorted chronologically in descending order according to the date of submission. Here is an example of an episode of the show “Bad Banks”:

There, in addition to the **product title** (as well as original, episode or subtitle) (1), you will also find, depending on media type and availability, various other information, such as **product id** (2), excerpts from the **cast list** (3), as well as **genre, production or recording year or production length** (4).

The lower third of the production tile offers further information and options that improve the transparency of the registered contributions.

In addition to the aforementioned **transmission mast icon** (1), which indicates a currently relevant use of the production by means of blue coloring, this also includes the option of using the "**Product details**" button (2) to open the corresponding production in the product search, including any additional information available there. The processing status

The production-based view of the registered section shows at a glance how many contributions have been registered for a production and in which processing status they are: the correspondingly colored symbol at

the bottom left (highlighted here by an arrow) provides information on how far your registration has already been processed.

Above the symbol you will find details of the contributions you have submitted on the product under "Contribution reports" (1):

If only one contribution has been registered for the corresponding product, the most important information about this submission will be displayed briefly and concisely:

- the current processing status (2), indicated by the corresponding symbol
- the contribution id (3), under which the registration is managed within GVL
- the specified contribution role (4) or additional details of the contribution.

If **several contributions** have been registered for one production, this is initially indicated by "Several contributions".



Clicking on the **arrow symbol** (1) opens the **detailed view** (2) for all received contribution reports - which is closed again with a second click. At the same time, in the case of multiple registrations, several **overlapping symbols** (3) for the respective processing status can be found in the lower left corner according to the number of contributions submitted. In the case of an existing verified registration, the green indicator is always displayed as the "topmost" one.



Additional information can also be displayed for each submitted contribution. To do this, simply click on the **small arrow** (4) on the right-hand side next to the corresponding submission.

Here, in addition to the time of the report ("Reported at:"), the specified parameters can be viewed depending on the product type (e.g. sound recording or TV production). For example, the number of shooting days or takes, the year of contribution and, in the case of contributions to audiovisual productions, the role name.

In addition, the **rejection reason** is also displayed in case of declined contribution registrations.



Register radio/TV extra formats

The Radio/TV extra formats are a comparatively small sub-budgets, which accounts for less than 3 percent of the total distribution volume of GVL for artists per year of use, and for which we are unable to provide usage reports from the TV and radio stations. The distribution amounts result primarily from private copy levies and are only settled once as part of a final distribution.

Contribution reports for productions that belong to the Radio TV extra formats are not submitted via the product search of the artist portal, but via a **separate online form**, that you can access by clicking on the corresponding button in the main menu. More information, as well as links to the most important questions and answers, can be found on our homepage.

Since we can not provide an English version of the form, we've created a glossary sheet with the most important key words and explanations. It can be found here.

Register small literary formats

A small literary format (SLF) is defined as a short spoken radio contribution, usually one to two minutes long (but no longer than 10 minutes), which is included in broadcasts that are not made available in the product search.

This can be, for example, a daily changing sketch in a morning magazine or the recitation of a poem in a program not available in the database due to content generally irrelevant to performance protection law.

If you have participated in a production to which the above applies, you can use an online form to create a new small literary format and register a contribution for it.

To do this, click on the button "**Register small literary formats**" in the main menu.

- **Participation role** (4): The **type of your contribution**. Only the roles "**artistic speaker/narrator**" and "**dubbing director**", which are relevant in the spoken word area, are available here. Multiple entries are possible if you have performed both activities.

The lower, red-colored button "**Remove**" (1) deletes all broadcast information if you want to undo a reporting step.

The **view summarizes the submitted formats** (1) and shows the entered parameters - year of recording or broadcast, production name & broadcasting station, production or broadcast duration, as well as the contribution role and the statement date.

If both possible contribution roles have been specified, the **respective reports** (2) are listed one below the other.

In the center, the **current processing status** (3) of the reported Small Literary Format is displayed; in addition, in case of rejected reports, the reason for the rejection can also be found by clicking on "Rejected" ("Abgelehnt") (4).


Clicking on the **bold title** (5) of a reported small word format uses the entered report parameters (production name, recording year, duration and contributor role) as a template in the form to submit a similar report - for example, for an additional year of use or a different radio station.

Please note that once a template is selected, the product details cannot be changed, only the contribution role and broadcast details.

The **buttons on the upper right side** (6) allow to export a list of already submitted reports as Excel spreadsheet or PDF document. The download starts automatically. In addition, a click on the "**Print page**" button triggers the print dialog of the browser used.

This provides an overview of the master data stored at GVL for the currently logged-in beneficiary. If rights holders are registered with GVL in several functions, they will have several IDs. If productions are also used internationally, an **IPN** (International Performer Number) may also be displayed with the personal data. It serves to identify rights holders in the international exchange of collecting societies.

Clicking on the corresponding button in the menu under the playing piece icon opens the "My documents" section, where you can view and manage the documents provided by GVL as part of its distributions.

For GVL members who have filled out a digital online performance contract, a copy of it can be found in an additional tab called "**Rights administration agreement**".

By clicking on the respective tab, the corresponding documents are displayed. GVL provides its rightsholders with two different types of documents - depending on the distribution: "**Payout information**" (1) and "**Detailed distribution reports**" (2). Further information on the differences and distinctive features can be found on our homepage.

In addition, a **link** (3) leads to the corresponding part in the "Frequently Asked Questions" on gvl.de. Please note that this link leads out of my.GVL and the page opens in a new window or tab.


The files provided by GVL are usually saved in "**Portable Document Format**" (.pdf) (payout notifications & detailed distribution reports). To view them, you will therefore need **Adobe Acrobat Reader** or an equivalent program that can open the file type (for example, "Preview" on Apple devices). We also provide detailed distribution reports as **Excel documents** (.xlsx), which can be opened with **Microsoft Office** or **Open Office**, for example.

According to their nature, the stored documents are grouped either by **payment year** (Payout notifications), i.e. the year in which the remuneration was paid, or by **year of use** (Detailed distribution reports). Detailed reports contain all **remunerated contribution reports for a specific year of use**, so that it is possible to see how the claims for a specific year are made up.

"**Format & Language**" (2) indicates in which language and in which file type the document is available: Payout notifications are always stored in .pdf format.

Under "**Credit note number**" (3), the numbering of the respective document can be viewed at a glance without having to open or download the file. The "**Credit note date**" (4) indicates the date (in the format YYYY.MM.DD) on which the document was created.

Hovering over an entry (5) will highlight it in blue, clicking on it the list view automatically starts the download of the corresponding document. Depending on the settings of your browser, the file will open by itself afterwards. In any case, it can be found in the download folder of the end device used.

Detailed distribution reports

The detailed distribution reports not only indicate which productions have been remunerated for a specific year of use and to what extent, but also how high the expected total distribution for the respective year of use is. The projected sum shows how much money you are expected to receive at the end of the reporting period. Since this sum depends on a wide variety of factors, it is always adjusted. For this reason, each year you will receive a new, updated version of the detailed report and thus also of the projected total for the year of use. For this reason, the stored documents here are not sorted by creation date, but by the individual years of use.

Clicking on one of the **arrows** within a tile in the "Detail distribution reports" tab opens the list overview of all documents that have been created for the corresponding year of use.

Different columns provide additional information about the respective document. The "**Document type**" (1) indicates that the available files are detail reports. Since detail reports are available in German and English,



as well as in the file types .pdf and .xlsx, the column "**Format & Language**" (2) indicates which specific document is it.

The "**Reference number**" (3) shows how many distributions have already been made for the respective year of use. In this way, it is possible to distinguish more quickly between different detailed reports for a year of use. Please note that detailed distribution reports for the Radio/TV-extra formats are always labelled with the reference number 99. The "**Receipt date**" (4) informs about the date (format YYYY.MM.DD) on which the corresponding detail report has been created. The most recent detail report can always be found at the top of the list.

Clicking on an **entry** (5) in the list view automatically starts the download of the corresponding document. Depending on the settings of your browser, the file will open by itself afterwards. In any case, it can be found in the download folder of the end device used.



You can mark individual tracks/episodes to which the proof documents you upload refer. After submitting, a new case is created with the remaining tracks/episodes.

2. Case type „Rejection / Appeal“

This case type is created when one of your contribution registrations has been rejected. The display corresponds to the "Upload evidence" case type: In the header you will see the **due date** (1), the **case ID** (2) and the **relevant title information** (3). Please note: An appeal to a rejection can only be submitted up to the due date.

3. Case type „Acknowledge refusal of appeal“

If your objection is rejected, you will also be informed of the reason for rejection in the detailed view of the case. There is no possibility to object again. You can take note of the rejection by pressing the corresponding button.

4. Case type „Acknowledge refusal“

In this type of case, it is no longer possible to file an objection. These are usually a) rejections for which the objection period has expired, or b) rejections of duplicates, i.e. contributions that already exist identically for this production and are therefore redundant. In this case, the rejection reason always contains a note on the already existing contribution and the corresponding contribution number, e.g. "A contribution with an identical role name has already been registered. See 123456789."

5. Case type „Acknowledge registration error“

This case type displays contribution registrations that cannot be processed further for technical reasons and must therefore be rejected. For example, important information may be missing, such as the selection of a function or the specification of shooting days or takes - depending on the type of contribution. You will find a concrete reason for the rejection in the detailed view of the case.

Usually, when registering a contribution, all necessary parameters must be specified so that such faulty reports do not arise in the first place. However, due to the complexity of the different combinations of contributor roles, genres and media types, this "safety net" has not always worked in the past, so that occasionally defective reports still have to be retrieved and rejected.

Please check if there is already a correct report for this production. If necessary, report again or feel free to contact us if you are unsure.

6. Case type „Acknowledge contribution conflict“

If you have contributed to a production in numerous ways, you generally have the option of submitting reports for all of these different activities, provided that GVL evaluates the respective contribution role. However, there are activities that cannot be reported at the same time because they contradict each other. For example, it is not possible to report both roles as conductor and studio conductor in one production, or artistic producer and conductor at the same time. If such a contradictory report is detected, it will be rejected. In the details of the case, you will find the reason for rejection with a reference to the existing report.

The high number is due to the fact that we want to provide you with the most detailed information possible. Especially the case type "Acknowledge registration error" can display a multitude of faulty combinations in relation to a contribution report.

Each reason for rejection contains the transaction number to which it refers, represented here by {0}. Some rejection reasons also refer to an already existing, different report and contain its contribution number for traceability, represented here by {1}. You can find an overview of your existing contribution reports in the "Registered" area.

- A contribution with an equivalent combination of role, function and, if applicable, vocal range/instrument has already been registered. See {1}. (Case number: {0})

- This is no instructing, artistic activity in terms of neighbouring rights, as no other artists were instructed during the recording. (Case number: {0})
- The proof does not confirm your contribution. Please submit credits of the recording or send a new valid proof. (Case number: {0})
- There already exists an equally valued, verified contribution registration as a soloist for this production. (Case number: {0})

- The activity of voice over or translation is irrelevant under ancillary copyright law. (Case number: {0})
- Factual and informational texts are irrelevant under ancillary copyright law. (Case number: {0})
- Not a small spoken word format! Please report your participation under radio production spoken word. (Case number: {0})
- The selected role is not applicable for this product. (Case number: {0})
- The music part is missing. (Case number: {0})
- This function is not applicable for the selected role. (Case number: {0})
- The selection of a role is missing. (Case number: {0})
- The selection of an instrument/voice range is missing. (Case number: {0})
- A contribution as a singer requires the selection of a voice range, not the selection of an instrument. (Case number: {0})
- A contribution as a singer requires the selection of a voice range. (Case number: {0})
- A contribution as an instrumental musician requires the selection of an instrument, not the selection of a voice range. (Case number: {0})

I receive an error message when logging in - what can I do?

If you receive an error message when trying to log in to our artist portal, please follow these steps:

1. First, check which browser you are using. We recommend [Google Chrome](#) or [Firefox](#). Apple's standard browser *Safari* is unfortunately only partially compatible with our portal and using it often leads to error messages.
2. Delete cookies and cache of your browser. This works differently depending on the browser you use:
Firefox: Menu → Preferences → Privacy & Security → Cookie and Site Data → Clear Data
Chrome: Menu → More tools → Clear browsing data → Clear Data
3. Please make sure that you use your **contract number** and not the GVL ID to log in and check the correct spelling and capitalization of the password.
4. If necessary, click on the "Forgot password" button to receive a link for a new password and then try again. For more information, [see the corresponding chapter above](#).
Important: the password must not contain special characters, must be at **least 8 characters long**, and must contain **at least one uppercase letter, one lowercase letter and one number**.
Please note that the link can be used only once - after that it is invalid and it is not possible to create a new password again using it.

Why can't I find a specific production?

1. First, check the **spelling**: The production is not always published under the title under which it was produced. GVL is usually only reported the title under which the production was published and broadcast in Germany. However, you can usually find out the broadcast title via the producer/label or an Internet search.

2. Customize the **display** of the results. Are the sorting and the number of search results per page selected appropriately to be able to see the production? Is there possibly still a filter set that unintentionally restricts your search?

3. In addition, there may be other reasons why a search comes up inconclusive:

- The program information that we obtain from an external provider must first be technically processed before we can make it available in our database. As a rule, the productions of the current year are available in the portal in April/May of the following year. So if the production you're looking for was broadcast only recently, it probably hasn't found its way into our database yet.
- Certain production types, which belong to the Radio/TV extra formats, cannot be found in our database for cost reasons. We will inform you about the current reporting modalities for these production types [here](#).
- In accordance with its distribution plans, GVL only evaluates stations that meet certain requirements, such as a minimum reach. Online usages, for example in media libraries or on streaming portals, are not evaluated by GVL because the legal framework conditions do not allow us to do so. Should anything change in this regard, we will of course inform you.

If you are unable to find the productions you are looking for, even though these conditions are met, please contact the [corresponding specialist team](#) who will be happy to assist you in your search.

I have accidentally reported a wrong production or entered incorrect parameters. What can I do?

Currently, you do not have the possibility to delete or edit submitted reports. If you wish to correct your report, please contact the corresponding specialist team. Please note that for reasons of transparency, we cannot completely delete reports, but only reject them.
